General Conditions of Sale

1. THESE CONDITIONS OF SALE unless otherwise agreed in writing by the seller shall override any terms or conditions stipulated, incorporated or referred to by the buyer in his order or negotiations.
2. CLAIM LIMITATION Any claim by the buyer that the goods are not in accordance with the specification is limited to the replacement by the sellers of the goods supplied.
3. QUANTITY OR QUALITY CLAIMS on goods dispatched will not be entertained by the seller unless they are notified in writing within 14 days of the receipt by the customer, and are afforded the opportunity of seeing the goods which shall have been cut, printed or processed or used by the buyer and in any event the claim will be limited to the value of the goods supplied.
4. The seller will not entertain CLAIMS FOR DAMAGE OR NON DELIVERY of goods unless they are notified in writing within 5 days of the invoice date.
5. FAILURE TO DELIVER within the time stated on the part of the sellers shall not entitle the buyers to any claim upon the sellers by reason of such failure. The sellers cannot accept cancellation if the goods are in the course of manufacture or transit.
6. SUITABILITY OF GOODS for any specific purpose cannot be guaranteed by the sellers.
7. COST VARIATION Quotations are based on the current costs of production and are subject to amendment by us on, or at any time after acceptance to meet any rise or fall in such costs.
8. VALUE ADDED TAX We shall be entitled to charge the amount of any value added tax as required by law.
9. VARIATION IN QUANTITY AND QUALITY Every endeavor will be made to deliver the correct quantity ordered, but quotations are conditional upon a margin of 10% . For small orders of value typically less than £400 variations may be + or – 20%.

10. CUSTOMERS PROPERTY AND PROPERTY SUPPLIED Customers property and all property supplied to us by or on behalf of the customer will be held at customers risk. Where the customer supplies materials adequate quantities shall be supplied to cover spoilage.
11. FORCE MAJEURE Every effort will be made to carry out the contract, but its due performance is subject to cancellation by the seller or to such variations as he may find necessary as a result of inability to secure labour, materials or supplies or as a result of any Act of God, War, Strike, Lockout or other labour dispute, Fire, Flood, Drought, Legislation or other cause (whether of the foregoing class or not) beyond the sellers control.
12. OUR TERMS for sales on account are strictly nett, 30 days from date of invoice.
13. TITLE OF GOODS – THE SELLER RETAINS TITLE TO GOODS DELIVERED UNTIL ALL MONIES OUTSTANDING ARE RECEIVED FROM THE BUYER AND ONCE OVERDUE, THEY OR GOODS TO THE VALUE OF CAN BE RECLAIMED AT ANY TIME WITHOUT NOTICE.
14. SETTLEMENT OF CLAIMS The sellers decision on all matters relating to the settlement of claims shall be final and the seller may at his option either replace any goods which he finds to be faulty or pay or allow to the buyer, a reasonable sum not exceeding in any event the invoice value of the faulty goods. Complaints in respect of alleged faulty goods shall not be a ground for withholding payment by the buyer of his accounts and shall not give any right of set off against payments due from the buyer to the seller. Should either company have financial difficulties then amounts to and from both companies may be subject to contra account, even if this is not the usual manner of trading.
